Because of the generosity and determination of community members, the Hospital opened its doors in September of 1981. In 1996, the Hospital became a proud part of Tahoe Forest Health System. Tahoe Forest is one of the top 100 Critical Access Hospitals in the country, has achieved notable quality measures that demonstrate the highest patient safety standards, and consistently exceeds patient satisfaction ratings.

DID You KNOW?

With help from our generous community of donors, the Incline Village Community Hospital Foundation was able to elevate patient care by purchasing and/or committing to funding the following life-saving equipment and services:



ADVANCED DIAGNOSTIC EQUIPMENT

Over the last two years, the IVCH Foundation has been the honored recipient of \$3.7 million in Diagnostic Imaging Improvement funding from The Leona M. and Harry B. Helmsley Charitable Trust. A project of this scope required adjunct fundraising efforts on behalf of the Foundation. With committed support from our donors, we delivered the following advanced diagnostic and radiology equipment for our Hospital:

128 SLICE CT

A **128 slice CT** has the ability to acquire up to 128 images in a single rotation. This advanced speed can provide higher-resolution images of the entire body in less than one minute.

FIXED X-RAY DEVICE

Our new **Fixed X-Ray device** delivers faster image acquisition, higher image quality, and the ability to store images electronically.

POINT OF CARE ULTRASOUND (POCUS)

Often used alongside physical exams, **POCUS** improves diagnostic accuracy and reduces the need for additional exams or redundant interventions. Providing faster, more targeted treatment saves lives.

3D MAMMOGRAPHY

By offering higher level visual clarity, **3D Mammography** provides improved detection accuracy and decreases the number of false positives. This contributes to fewer repeat imaging requests and additional testing. Most importantly, early cancer detection is key to effective treatment and increased survival rates.



BEHAVIORAL HEALTH SERVICES

Local access to Behavioral Health Services was supported by \$114,000 in grant funding, giving the IVCH Foundation an opportunity to subsidize the important work of a Licensed Clinical Social Worker and a Psychiatric Nurse Practitioner




ORAL HEALTH

As part of the Incline Village Oral Health Improvement for Children initiative, the IVCH Foundation is utilizing a \$120,000 Oral Health Grant to continue servicing our community's students each school year by facilitating an operation that provides free dental health screenings, fluoride varnishes, and restorative dental care



Area of Greatest Need

When you designate your gift to our Area of Greatest Need, the Foundation Board of Directors will direct your contribution toward the Hospital's most significant need. In our undertaking to offer the best patient care experience possible, having access to comprehensive services and programs — as well as state-of-the-art technology and diagnostic equipment — is a vital necessity.

Access to a nearby Emergency Room that provides comprehensive patient care is lifesaving.

Gifts of Cash

Gifts of cash, by check or credit card, are the most direct ways to give to the IVCH Foundation. As a not-for-profit 501(c)(3) organization, your gift is tax deductible to the full extent allowed by law.

Gifts of Securities

After being held for a minimum of one year, stock that has increased in value is one of the most popular assets used for charitable giving. Donating appreciated securities is a simple gift that can offer you a greater tax benefit than an equivalent in cash. Using appreciated securities entitles you to a charitable deduction for the fair market value of the donated asset. You also avoid paying the capital gains tax you might owe if you sold the appreciated securities.

Gifts From a Retirement Plan

If you are required to take a minimum distribution from a retirement account, a Qualified Charitable Distribution can be made directly from an IRA to the IVCH Foundation. This will allow you to lower your gross income, and possibly reduce your income or estate tax by transferring the additional taxable income to the IVCH Foundation.

Gifts From a Donor Advised Fund

A Donor Advised Fund, or DAF, is like a charitable investment account. You are generally eligible to take an immediate tax deduction when you contribute assets from a DAF. You can recommend grants to the IVCH Foundation from this type of tax-free investment fund.

Gifts From a Matching Gift Program

Double your donation to the IVCH Foundation. Many employers sponsor matching gift programs that will match any charitable contribution made by their employees with a ratio that is often 1:1. By taking advantage of such a program, you can effectively double the impact of your gift.



If you are interested in supporting the long-term vision of the Incline Village Community Hospital, you can make a plan to give to the IVCH Foundation in the future. This enables us to continue supporting the life-saving services we offer to all of our community members. There are numerous estate planning techniques that can maximize your testamentary charitable giving while mitigating tax exposure. Please consult your tax advisor or estate planner for more information about tax deductions for charitable donations, and review a few of the options below:

Will or Trust Bequests

These gifts are made by including a provision in your will or trust document. The IVCH Foundation receives your gift after your passing, at which time your estate can take the income and estate tax deductions.

· Charitable Lead Trust

A charitable lead trust would pay the IVCH Foundation for a certain number of years with the trust principal returning to you, your family members, or other heirs. It can be an excellent estate planning vehicle if you own assets that will substantially appreciate in value. It can help you keep an asset in the family, while also enjoying some tax benefits.

· Charitable Remainder Trust

A charitable remainder trust is the mirror image of the charitable lead trust. Trust income is payable to you, your family members, or other heirs for a period of years. The principal would then be directed to the IVCH Foundation. A charitable remainder trust can be beneficial because it provides you with a stream of current income.

Donors who notify the Foundation of their intention to include the IVCH Foundation in their will or trust are instated as an *IVCH Foundation Legacy Partner in Health* member. Based on donor preference, the Foundation would like to thank and recognize supporters for their intention to give while they are still living.
